What is this product?

TYPE OF PRODUCT

The product is a Sub-Fund of ZEST ASSET MANAGEMENT SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the Fund may at any time be dissolved by a resolution of the general meeting of shareholders subject to the quorum and majority requirements applicable for amendments to the Articles. And, in the event that for any reason the value of the net assets in the Sub-Fund or Class has decreased to an amount below EUR 10 million or the equivalent in any other Reference Currency, respectively such amount determined by the board of directors to be the minimum level for such Class to be operated in an economically efficient manner, or if a change in the economic or political situation relating to the Sub-Fund or Class concerned would have material adverse consequences on the investments of the Sub-Fund or Class or in order to proceed to an economic rationalization, the board of directors may decide to compulsorily redeem all the Shares issued in the Sub-Fund or Class at the Net Asset Value per Share (taking into account actual realization prices of investments and realization expenses) calculated on the Valuation Day at which such decision shall take effect.

OBJECTIVES

The Sub-Fund has for objective to provide its investors with a medium-long term capital growth, by a diversified portfolio of equity securities issued by international companies listed on official stock markets and debt securities issued by international issuers. The Sub-Fund is actively managed without reference to any benchmark.

The investment approach follows an active management strategy without regard to geographical or sector allocation, security type or size. The same investment policy may be applied through investment in units of UCITS and other UCIs (within the below limit).

The Sub-Fund may also invest in unquoted securities in accordance with the limits set forth in Part A of the prospectus.

For the avoidance of doubt, the convertible bonds are to be considered as debt securities and shall therefore be aggregated to the ratios applicable to debt securities.

Subject to the provisions set forth in Part A of the prospectus:

the equity or equity-related securities will not exceed 90% of the net assets;

no more than 50% of the net assets in equities quoted on emerging countries' stock exchanges;

no more than 50% of the net assets in non-investment grade bonds, including bonds issued in emerging countries.

It is understood that these limits only apply to direct equities, bonds and related securities and UCITS and/or UCIs investing principally in equities and bonds; i.e. financial derivative instruments on equities or on bonds are not taken into account for the calculation of these restrictions.

The Sub-Fund will not invest:

directly in ABS/MBS. It shall however be mentioned that this ABS/MBS restriction that apply to direct investment in this asset class is waived for:

- investment in Exchange Traded Commodities (ETC) when seeking exposure to commodity markets (according to the Law of 2010, CSSF Circulars and without any possibility of deliverable commodities) when such ETC are structured as ABS or MBS. In any case, such investments in ETC (whatever their structuration being) will not exceed 20% of the net's assets of the Sub-Fund;
- more than 10% of its net assets in the units or shares of UCITS or other UCIs;
- in contingent convertible bonds;
- in total return swap.

It should be noted that the investment in units or shares of other UCITS and UCIs may entail a duplication of certain fees and expenses. If the Sub-Fund invests in units or shares of UCITS or UCIs managed by the investment managers' group, no subscription or redemption fee will be charged for investments by the Sub-Fund into other investment funds of the investment managers' group.

The Sub-Fund may also hold ancillary liquid assets (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes. The aforementioned limit shall only be temporarily breached for a period of time strictly necessary when, because of exceptionally unfavourable market conditions, circumstances so require and where such breach is justified having regard to the interests of the Shareholders.

The Sub-Fund may also hold on ancillary basis money markets instruments dealt in on the money market.

The Sub-Fund issues only accumulation shares (shares in which any income earned is added to the share price).



The Sub-Fund's assets are held with Pictet & Cie (Europe) S.A. and are segregated from the assets of other Sub-Funds of the Fund. The assets of the Sub-Fund cannot be used to pay the debts of other Sub-Funds.

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 3 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

A redemption order is executed at the redemption price ruling on a Business Day (a full business day on which banks are fully open in Luxembourg), the application for the redemption of shares must reach the Administration Agent (FundPartner Solutions (Europe) S.A.) before 12:00 p.m. (Luxembourg time) on the Business Day preceding the relevant Business Day.

How can I complain?
