What is this product?

TYPE OF PRODUCT

The product is a Sub-Fund of ZEST ASSET MANAGEMENT SICAV, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However, the Fund may at any time be dissolved by a resolution of the general meeting of shareholders subject to the quorum and majority requirements applicable for amendments to the Articles. And, in the event that for any reason the value of the net assets in the Sub-Fund or Class has decreased to an amount below EUR 10 million or the equivalent in any other Reference Currency, respectively such amount determined by the board of directors to be the minimum level for such Class to be operated in an economically efficient manner, or if a change in the economic or political situation relating to the Sub-Fund or Class concerned would have material adverse consequences on the investments of the Sub-Fund or Class or in order to proceed to an economic rationalization, the board of directors may decide to compulsorily redeem all the Shares issued in the Sub-Fund or Class at the Net Asset Value per Share (taking into account actual realization prices of investments and realization expenses) calculated on the Valuation Day at which such decision shall take effect.

OBJECTIVES

The Sub-Fund aims to seek an absolute return, while placing emphasis on the preservation of capital in the medium-term period. The investment strategy is based on a combination of direct investments in equities and bonds.

The Sub-Fund is actively managed. The Sub-Fund has no benchmark index and is not managed in reference to a benchmark index.

The Sub-Fund will invest primarily in Europe (included United Kingdom) and North America.

The allocation of the portfolio may vary. However, the Sub-Fund will invest a maximum of 40% in equities and equity-related securities (e.g. convertible bonds, equity linked notes, financial derivative instruments underlying equities or eligible equity indices (e.g. options, futures), low exercise price warrants and warrants on equities); 90% fixed income instruments, money market instruments, cash and cash equivalents; 100% in EUR denominated assets; 40% in USD denominated assets; and 20% in assets not denominated in USD or EUR.

Financial derivative instruments shall be used for hedging and for investment purposes. Options will be largely favoured for implementing the synthetic long or short strategy, but the Sub-Fund may also invest in CFDs or futures.

Exposure to emerging and frontier markets (defined by MSCI) will be limited to 10% of the net assets. In addition, the Sub-Fund may be exposed to Russia for a maximum of 10% of the net assets.

Fixed income instruments rating (long-term rating by S&P (or by Moody's or Fitch) at issue or issuer level) shall range from at least B to Investment Grade. Money market instruments rating (short-term rating by S&P (or by Moody's or Fitch) shall be at least A3. In case of downgrading, the Investment Manager may keep the investment in the best interest of shareholders.

If the issuer/the issue is not rated by a recognized agency, the board of directors may, in its discretion, appreciate whether one instrument possesses the equivalent of at least High Yield rating criteria (this criteria assessment will be monitored by the Investment Manager on an ongoing basis). Non-rated fixed income instruments will be limited to 10% of the net assets.

The Sub-Fund will not invest more than 20% of its net assets in other UCITS and/or UCIs, Exchange Traded Funds.

The Sub-Fund will not invest:

directly in ABS or MBS. This ABS/MBS restriction is waived for:

- indirect investments such as target funds (i.e. no look-through);
- investment in Exchange Traded Commodities (ETC) when seeking exposure to commodity markets (investments in ETC will not exceed 20% of the net assets);
- in contingent convertible bonds;
- in structured products;
- total return swaps.

The Sub-Fund may also hold ancillary liquid assets (i.e. bank deposits at sight, such as cash held in current accounts with a bank accessible at any time) up to 20% of its net assets for treasury purposes. The aforementioned limit shall only be temporarily breached for a period of time strictly necessary when, because of exceptionally unfavourable market conditions, circumstances so require and where such breach is justified having regard to the interests of the Shareholders.

The Sub-Fund issues only accumulation shares (shares in which any income earned is added to the share price).

INTENDED RETAIL INVESTORS

The product is reserved for professional investors. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

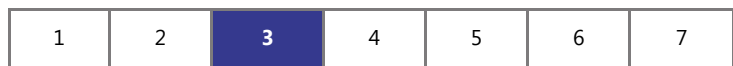

What are the risks and what could I get in return?

The Sub-Fund's assets are held with Pictet & Cie (Europe) S.A. and are segregated from the assets of other Sub-Funds of the Fund. The assets of the Sub-Fund cannot be used to pay the debts of other Sub-Funds.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

- EUR 10,000 is invested

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 5 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

A redemption order is executed at the redemption price ruling on a Business Day (a full business day on which banks are fully open in Luxembourg), the application for the redemption of shares must reach the Administration Agent (FundPartner Solutions (Europe) S.A.) before 12:00 p.m. (Luxembourg time) on the Business Day preceding the relevant Business Day.
